### 9. NOTICE AND QUORUM OF GENERAL COUNCIL

Notice of the general meeting will be issued with the signature of the president through notice or eventually through part to served 8 days period to the meeting. If 2/3 of the total members (which will be quorum) are not present, then the meeting will be postponed and proposed meeting will be held on the same days after 1/2 an hour and there will be no restriction of the quorum to this meeting. This fact should be mentioned in the notice.

### 10) . SPECIAL GENERAL MEETING AND ITS FUNCTIONS :

Special meeting can be called by issue of the notice with the signature of President through notice board or eventually through part, period to 10 days of the meeting. Important issue like, change the name of institutions, amalgamation liquidation, change the objective or any other urgent issue in the introit of the institutions will be taken up in the meeting.

## 6 . TYPES OF MEMBER

**a)Founder Member** :- Those who signed the memorandum of association and was present the 1-2-99 meeting will be the founder member of the society and there is no any need of fee for their membership .

**b) Life -Member** :- Those who will pay 101/- (Five hundred one) or more than this amount such donor can become the life member of the institution and his member shall will be as a life member . Entry to Rs 51 /- will be changed separately .



### **11) FORMATIONS OF THE EXECUTIVE COMMITTEE OF THE INSTITUTIONS AND ITS CHAIR PERSON**

### **12 .TENURE THE EXECUTIVE COMMITTEE AND PROCEDURE OF THE ELECTION**

Term of the Executive Committee will be 5 (five) years . Every five years there will be election for Executive Committee . Executive Committee will be elected in general meeting by raising hands . If 2/3 ask for secret voting then will be secret voting .

### **13) CHAIR PERSON OF THE EXECUTIVE PERSONS AND THEIR FUNCTIONS**

If the requisitioned is not called by the President in that case two members from the members who requisitioned meeting should issue the notice with their signature out of them one will preside over the meeting as a chairman (President) and the resolution, decisions Executive Committee.



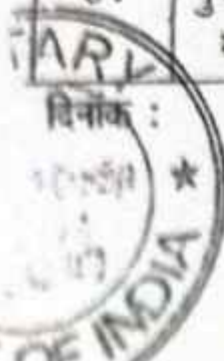
